Attached for your consideration is a Resolution requested by the Mayor appointing Charles Kilgore to the Dundee Business Improvement District Area Board to replace Mary (Abby) Klusmire whose term ends on March 23, 2013.

WHEREAS, Section 19-4022 of the Nebraska Revised Statutes provides that a Business Improvement Board shall consist of five or more members; and,


WHEREAS, the term of Mary (Abby) Klusmire as a member of the Dundee Business Improvement Area Board expired on March 23, 2013; and,
