

ORDINANCE NO. _____

AN ORDINANCE to amend the official records, logs, and plats of the City of Omaha by providing for the change in the street names for the following five streets in the Coventry Addition, a subdivision in Douglas County, Nebraska: 210th Street, Washington Street, 209th Avenue, and Spence Drive; and to provide for the effective date.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

Section 1. That, notwithstanding the provisions of Chapters 27 and 34 of the Omaha Municipal Code, the official records, logs, and plats of the City of Omaha, maintained pursuant to the Omaha Municipal Code, be amended to provide for the following changes in street names:

- a) 210th Street changes to Spence Drive, from Harrison Street north to Washington Street.
- b) Washington Street changes to Spence Drive, from Spence Drive, northeast to Coventry Drive.
- c) 209th Avenue changes to Jefferson Street, from Washington Street northwest to George B. Lake Parkway.
- d) Spence Drive changes to 210th Street, from Washington Street north to George B. Lake Parkway.
- e) Spence Drive changes to 209th Street, from Washington Street southeast to approximately 125 feet south of vacated Jefferson Street.

These changes are further illustrated on Exhibit "A" attached hereto and made a part by this reference.

Section 2. That this Ordinance shall be in full force and take effect on whichever dates occurs later: a) fifteen (15) days from and after the date of its passage, or b) upon the recording




SUBJECT AREA IS SHADED











Spence Drive change to S 210th St





REQUEST: Street name changes from Spence Drive to 209th Street, from Washington Street southeast to approximately 125 feet south of vacated Jefferson Street.
