



ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE to accept the bid from Alamar Uniforms with its principal place of business at 3105 Leavenworth Street, Omaha, Nebraska, involving the payment of money from appropriations of more than one year in accordance with Section 5.17 of the Home Rule Charter of the City of Omaha, 1956, as amended; to provide firm price commitments per item for two years, on Omaha Police Department standard uniform items, which are to be provided to members of the Omaha Police Department, although prices have been specifically determined by the bid, the exact costs are indeterminate and will vary depending on the purchases, they are anticipated to be in the approximate area of, with the possibility of exceeding, the sum of \$500,951.80, over the two year period; and to provide the effective date hereof.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

Section 1. Approval is hereby given to Alamar Uniforms who has submitted the only bid within bid specifications, at the bid opening of August 17, 2011, by which they have guaranteed to provide items designated within the bid and for a period of two years, with the option for one one-year extension at the sole discretion of the City, and may be done so administratively. Prices are to be firm for two years from date of award of contract. Any requests for price adjustments at the end of the two-year term, and optional year thereafter, must be accompanied by documentation and approved by the Omaha Police Department and the City of Omaha. Price adjustments shall not exceed the change in the Consumer Price Index for the extension year and will be based on the final month of the contract year just completed. Although prices have been specifically determined by the bid, the exact costs are indeterminate and will vary depending on the purchases, they are anticipated to be in the approximate area of, with the possibility of exceeding, the sum of \$500,951.80 over the two year period.

Section 2. All payments for such uniforms under such bid shall be paid from the Omaha Police Department General Fund 11111, Organization 113132 Police Supply, Account 46622 Police Uniforms/Expendable.

Section 3. This Ordinance, being not of a legislative character, shall be in full force and take effect immediately upon passage under and by virtue of the authority granted by Section 2.12 of the Home Rule Charter of the City of Omaha, 1956, as amended.

## SPECIFICATION FOR OMAHA POLICE DEPARTMENT UNIFORMS

### I. General

This Request for Bids is designed to solicit proposals from qualified vendors to provide uniforms and equipment to the Omaha Police Department. A price agreement will be awarded to a single vendor as a result of this proposal. Proposals that do not conform to the mandatory items as described in the proposal instructions and specification list will not be considered. The Omaha Police Department and the City of Omaha reserve the right to reject any or all proposals in whole or in part, and may, at their sole discretion, withdraw, amend, or extend this request prior to award.

The Omaha Police Department currently has approximately 800 uniformed personnel. It is planned that over a three-year period, four complete uniforms (minus hats and ties) for each officer will be purchased from this agreement in addition to companion equipment as needed.

### II. Quantities

Quantities listed on the bid sheet are estimates of annual purchases. Items will be ordered as needed. There shall be no limitation on order quantity, and the bid price shall apply to any size order.

### III. Term

The contract shall run for two years with an option to extend for one year from the date of the awarding of the contract at the sole option of the Omaha Police Department.

### IV. Renewal

This contract may be renewed after the initial term, one year at a time up to one year, at the sole option of the Omaha Police Department and City of Omaha, assuming that sufficient funding is made available to the City.

### V. Pricing

Bidder is required to quote unit prices. Prices to be firm for two years from date of award of contract. Any requests for price adjustments at the end of the two-year term, and optional year thereafter, must be accompanied by documentation and approved by the Omaha Police Department and the City of Omaha. Price adjustments shall not exceed the change in the Consumer Price Index for the extension year and will be based on the final month of the contract year just completed. Failure to reach agreement on pricing for the next year shall be grounds for termination of the contract.

VI. Guarantee

All bidders shall guarantee that the uniforms they propose to furnish are in accordance with the specifications required by the Omaha Police Department. The bidder's signature on the submitted proposal is a guarantee that the prices quoted have been arrived at without collusion with other eligible bidders and without effort to preclude the Omaha Police Department and the City of Omaha from obtaining the lowest possible competitive price.

VII. Quality

The uniforms shall be of the highest quality and durability. All items bid under the specifications must be nationally available and must have been made available to the trade for not less than two years.

VIII. Delivery Time (initial)

**Time is of the essence with regard to the delivery/receipt of the merchandise specified herein.** Successful bidder must furnish a local representative to provide fitting and measurement services.

**Local Stock**

Successful bidder shall be required to provide initial replacement uniforms within thirty (30) days of receipt of an initial purchase order from the City for local stock items. After the initial purchase, supplier shall be required to maintain a local stock of common shelf sizes for standard pants, short sleeve shirts, and long sleeve shirts for the immediate replacement within 48 hours. Non-standard sizes shall be available with five (5) working days.

**Custom Fitted**

Successful bidder shall be required to provide initial replacement of custom fitted uniforms within ninety (90) days of receipt of an initial purchase order from the City. After the initial purchase, supplier shall be required to provide custom fitted sizes within sixty (60) days.

**Special Orders**

Special order products (authorized equipment not normally stocked) shall be delivered within thirty (30) days of the order being placed by the City.

**Please ensure that your bid response specifically addresses delivery of the products outlined in this section.**

IX. Special Provision

The successful bidder must agree to sell any and all contract items to individual, sworn employees of the City of Omaha's Police Department at the same contract price for either local stock shelf items or custom fitted where local stock shelf items do not provide a reasonable fit.

Each bidder may be required to submit, along with their respective bid proposal, the following sample police uniforms:

1. One complete male uniform consisting of one long sleeved shirt, one short sleeved shirt, two pair of trousers (one with powder blue striping, one with gold striping), one eight-point uniform hat, one dark navy blue tie.
2. One complete female uniform, same as listed above, except for the tie and hat.

#### X. Emblems

The City of Omaha Police Department shall furnish to the bidder, official Omaha Police Department shoulder patches, which are to be stitched onto both sleeves, as noted in the specifications.

The City of Omaha Police Department shall furnish to the bidder, official Omaha Police Department buttons, gold and silver, which are to be attached to the uniforms, as noted in the specifications.

The bidder will be required to provide standard, military police style sergeant stripes, gold in color, as requested on command officer, long sleeved and short sleeved shirts. Gold must match command officer gold pant stripe.

#### XI. Proposal Evaluation

The Omaha Police Department will conduct a fair, impartial, and comprehensive evaluation of all proposals in accordance with the criteria set forth below. The criteria, in no particular order, for determining a qualified bidder shall include but not be limited to:

1. The ability, capacity, and skill of the bidder to deliver products and services that meet the requirements of this request for bids.
2. The character, integrity, reputation, judgement, experience, and efficiency of the bidder will be evaluated. Potential vendors and their employees are expected to demonstrate professional, ethical, and courteous business practices.
3. Performance of the bidder on prior contracts and during prior business encounters.
4. Other information that has a bearing on the decision to enter into a price agreement.
5. Cost.
6. Vendor can provide delivery service to the employee's work site or home.
7. Vendor provides service during evening and early morning hours.
8. Vendor provides service on weekends.
9. Vendor provides premium services not offered by other vendors.

#### XII. Evaluation Committee

Proposals will be evaluated by members of the Omaha Police Department Uniform Committee. Names of the members of the evaluation committee are not public information. Bidders are advised that only the point of contact (Captain Diana Kelly) can clarify issues or render any opinion regarding this request for bids. Bidders are prohibited from contacting members of the Uniform Review Committee or any other

member of the Omaha Police Department to discuss the terms and conditions of this proposal unless in response to an official request by the Department.

Violation of this condition may be considered sufficient cause to reject a vendor's proposal irrespective of any other condition. The only exception to this condition is contact made pursuant to any existing contracts or obligations.

### XIII. Communication with Staff

From the date this Request for Bids is issued until a determination is announced regarding the selection of the contractor, contact regarding this project between potential contractors and individuals employed by the Omaha Police Department is restricted to only written communication with the person designated as the point of contact for this Request for Bids.

Once a contractor is preliminarily selected, that contractor is restricted from communicating with Omaha Police Department staff until the bid is awarded. Violation of this condition may be considered sufficient cause to reject a contractor's proposal and/or selection irrespective of any other condition.

The following exceptions to these restrictions are permitted:

1. Written communication with the person designated as the point of contact for this Request for Bids or procurement;
2. Contacts made pursuant to any pre-existing contracts or obligations;
3. Omaha Police Department staff and/or contractor staff present at the Pre-Bid meeting when recognized by the Omaha Police Department as staff facilitating the meeting for the purpose of addressing questions; and,
4. Omaha Police Department-requested presentations, key personnel interviews, clarification sessions or discussions to finalize a contract.

### XV. Violation of Terms and Conditions

Violation of the terms and conditions of this request for bids or any resultant price agreement, before or after the award, shall be grounds for action by the Omaha Police Department and the City of Omaha which may include, but is not limited to, the following:

1. Rejection of the bidder's proposal;
2. Suspension from further bidding with the Omaha Police Department and the City of Omaha for a period of time relative to the seriousness of the violation.
3. Termination of Agreement.

Bid Sheet:

The City of Omaha intends to enter into a price agreement to supply police uniforms to the Omaha Police Department. This bid will be for two years with a one-year extension option. The City will have sole discretion on extending the option year. A price agreement will be awarded to a single vendor as a result of this proposal. Proposals that do not conform to the mandatory items as described in the proposal instructions and specification list will not be considered.

Bidder must provide trained personnel of the appropriate gender to take measurements. Times and dates to measure may be limited to vendor, but please note that scheduling restrictions will be considered when bids are evaluated. Best case scenario calls for measuring services to be available on demand.

Successful bidder will provide a local storefront or equivalent services. Equivalent services must include an account specialist assigned to manage OPD orders, a toll-free phone number and fax, rapid delivery of off-the-shelf products. Creativity in providing premium service is encouraged; please do not feel you are limited to just the listed considerations.

Special order products\* should be delivered within 30 days of order being placed. Please ensure that your bid response addresses this issue. (\*authorized equipment not normally stocked)

Vendor must be able to provide exact products as specified or equivalents, and must provide fast, reliable, quality service. **Equivalency will be determined by the Omaha Police Department.**

Vendor responses should include at least two references from two public safety organizations having more than 250 employees.
